## Disclosure Law Shields State Legislators, Donors

As the General Assembly debates who should control the State Bureau of Investigation's ability to probe political corruption, a new study says many state legislators are shielding themselves – and their donors – from scrutiny by filing incomplete, misleading, or hard-to-decipher campaign reports.

Under state law, legislative candidates must file six reports during the two-year campaign period to disclose who is donating to their campaigns and how the money is used.

But the election watchdog group Democracy North Carolina found that <u>92 of the 170 legislators</u> have sent the State Board of Elections paper reports during the <u>2014 campaign</u> instead of using software that makes the information easy for the board to examine and post quickly on its website for the public to view, in a searchable format.

Lawmakers filing paper reports, some in barely legible handwriting, include Senate President Pro Tem Phil Berger, House Majority Leader Edgar Starnes, and Senate Judiciary Committee Co-Chair Buck Newton. Legislators who consistently submit reports electronically, even though it's not required, include Speaker Pro Tem Paul Stam, Senate Majority Leader Harry Brown, and Senate Minority Leader Dan Blue.

"The paper reports pile up, and years can go by before the poorly funded Board of Elections has a chance to computerize the information and examine it for missing or inaccurate data," said Bob Hall, executive director of Democracy North Carolina. "Law enforcement agencies and the public are left in the dark because our campaign reporting laws are stuck in a pre-computer age."

Democracy North Carolina found more than 30 state legislators who have reports going back to 2010 that have not received the basic compliance review required by state law. Hall pointed out that NC General Statute 163-278.24 requires the board to examine each disclosure statement and "determine whether the statement conforms to law and to the truth."

A bill (H-919) that passed the NC House in 2013 with strong bipartisan support would require all candidates and political committees receiving over \$10,000 to file their reports electronically. The bill is now in the Senate Rules Committee, where its fate is unknown.

Hall said the bill would improve the public's "right to know" about political money and save the cost of paying board staff to enter data into electronic files before conducting a compliance review. The board needs the computerized data to compare, for example, what a candidate reports receiving from a PAC with what the PAC reports donating to that candidate.

Amy Strange,\* deputy director of the State Board of Elections, says the agency has "a large backlog of reports to audit." It receives an average of over 5,000 reports a year from candidates, PACs and party committees and can only process half that number with its current staff. Hall cited a few recent examples of problems and patterns that go undetected in the paper reports

that are simply scanned into unwieldy PDFs and posted on the board's website:

- Senate President Pro Tem Phil Berger's first quarter 2014 report says he has collected \$7,000 for the May primary from Jasie Barringer, chair of the beer wholesalers, R. H. Barringer Distributing Co. That amount is \$2,000 over the legal limit from an individual, but it's difficult to tell from Berger's 2013-2014 reports totaling over 360 pages if his campaign incorrectly added Barringer's multiple donations or refunded the excess money.
- Sen. Berger's first quarter 2014 report includes a large number of donations from beer wholesalers why? The total for that one report, much less the election cycle, is hard to determine because donors are arranged in order by first name, making it difficult to connect money from the donors' spouses and family members.
- Sen. Wesley Meredith's year-end report for 2013 lists more than three dozen donations from State Farm Insurance agents from all parts of NC which would be important for the public to learn about quickly since Meredith co-chairs the Senate Insurance Committee.
- Rep. Sarah Stevens' three reports submitted so far for the 2014 election are handwritten and do not provide any information about the occupation or employer of her donors, even for those giving her \$1,000.
- Sen. Ralph Hise's first quarter report for 2014 includes dozens of donations from \$100 to \$4,000 from individuals across the state with no occupational or employer information, which Hall said undermines the purpose of the disclosure reports and dramatizes why they need to be promptly examined by the Board of Election.
- Rep. Susan Fisher and Rep. Edgar Starnes seem to be in a contest for filing the most difficult-to-read handwritten reports.

Hall, whose study of campaign reports has led to investigations of Democrats and Republicans and their donors, said the lack of electronic reporting blocks effective oversight of the role of money in state politics. "Without reports being entered into the State Board of Elections' database, it is extremely difficult to track how much money is being donated by, say, the sweepstakes poker industry, or maybe the pharmaceutical industry, which is now seeking protection from lawsuits."

He pointed out that apparent campaign violations involving \$240,000 that sweepstakes owner Chase Burns donated to NC candidates and party committees in 2012 would likely have come to light sooner if reports were all filed electronically and compliance reviews initiated more quickly.

"Four years ago, Republican leaders promised to address what they called the 'culture of corruption' in Raleigh, but they have not passed a single law that would make it easier to track the flow of money in politics or punish wrongdoers," Hall said.

He noted that the stronger campaign disclosure requirements in H-919 have been endorsed by the John Locke Foundation and the NC Coalition for Lobbying & Government Reform.

Another House-passed bill (H-918) would require more rapid disclosure of the money spent by Super PACs, 527s and other groups not affiliated with candidates to influence election outcomes. It is also endorsed by a broad spectrum of liberal and conservative groups and was co-sponsored in the House by Republican David Lewis and Democrat Paul Luebke.

The state Senate has not taken up either bill.
