Includes donations from family members and in 3 cases from senior partners/bosses who often coordinate giving with Board member: J.K. Sherron Jr., head of J. K. Sherron & Associates, where Charles Grady works, Charles A. Hayes, chair of Guilford Mills where Doug Galyon is director of public affairs; John W. Harris, president of The Harris Group where Peter Pappas is vice president. Omits donations from other partners and business associates, and federal donations for 1990.
